Most importantly, they help us keep connected with our supporters by making calls and writing notes to express our thanks to all of you who make it possible for PCCT to achieve our mission.

As President, I want to express my personal appreciation to every volunteer who contributes to the success of PCCT—it certainly makes a difference for those whose lives are touched by this organization. I also want to thank you for your interest in, and support of, PCCT. We couldn't do it without you.

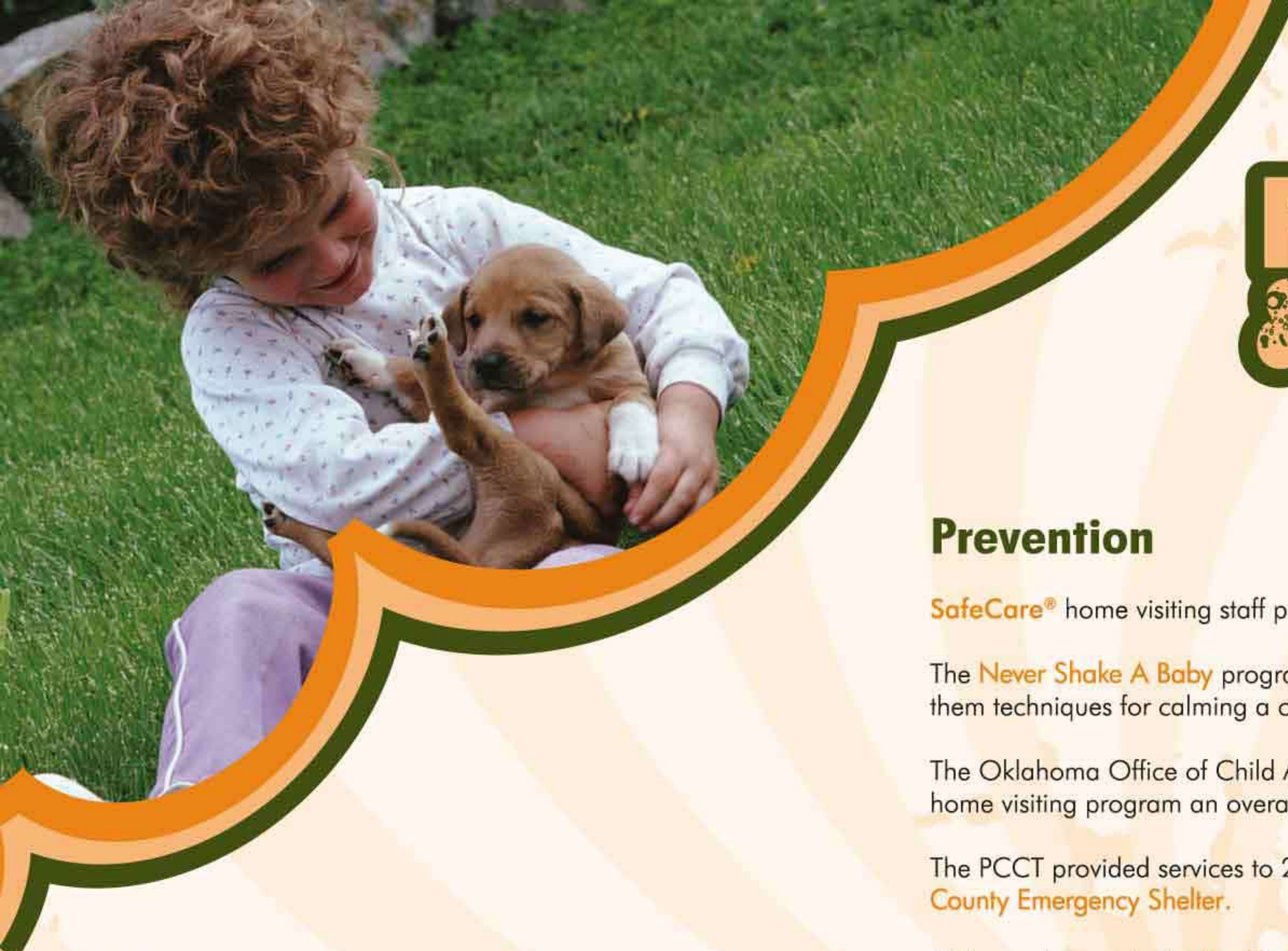

# PROGRAMS & SERVICES

## 2009 Highlights

### Prevention

**SafeCare**<sup>®</sup> home visiting staff participated in statewide training on child safety.

The **Never Shake A Baby** program visited 4,035 parents of newborns and taught them techniques for calming a crying baby and the dangers of shaking a baby.

The Oklahoma Office of Child Abuse Prevention gave our **GreatBeginnings Tulsa** home visiting program an overall excellent rating at our annual site visit.

The PCCT provided services to 285 parents and children residing at the **Tulsa County Emergency Shelter**.

135 people were in the **Healthy Start** program which provides education and support services at women's health clinics for moms-to-be and new moms to learn about their child's development and health, safety and nutrition needs, as well as the dangers of smoking, domestic violence, and substance abuse for their children.

We responded to 161 calls on our **24-Hour Hotline**.

### Nurturing Parenting

Parents in our 15-week **Nurturing Parenting** program demonstrated significant improvements in parenting skills, knowledge, and attitudes.

### Child Therapy

PCCT was selected to participate in a prestigious one year **Child-Parent Psychotherapy Learning Community** training program through the LSU Health Sciences Center. As a result of this training, our child therapists will work with other local organizations to expand mental health services for infants and toddlers in our community.

### Supervised Visitation

In July 2009, under a Tulsa Area United Way Venture Grant, we began partnering with Family and Children Services on the **Tulsa Families Together Project** and provided 156 hours of supportive visitation for DHS involved families in the first six months.

In 2009, the **Private Supervised Visitation Program** provided 925 hours of supervised visits and 63 supervised exchanges.

### Education

**Kids on the Block Puppets** grew tremendously with the support of the Sherman Smith Foundation.

- 11,047 Elementary students attended a puppet show
- 535 Performances for kids involved in various community programs
- 5 New puppeteers were trained

#### Parenting Resource Library

- 655 People contacted PCCT via the library
- 430 United Way presentation contacts
- 196 For the Children Tour attendees

#### Community Education/Speakers Bureau

- 430 People attended Tulsa Area United Way presentations
- 1,608 People attended presentations by the Speaker's Bureau
- 7,544 People attended presentations through community events

**Front Porch Project<sup>®</sup> of Tulsa** was launched with support from the Schusterman Foundation.

- 68 Community Presentations
- 170 Families (350 Parents & Children) Benefitted



Gone are the days when everyone gathered on the front porch and shared in the life of their community. But the needs of children for a safe and nurturing place to grow up have not changed.

**The Front Porch Project® of Tulsa**, a project of the American Humane Association, brings individuals and communities together through training to increase awareness about child safety issues, acquire valuable intervention skills, and increase comfort and willingness to intercede on behalf of a child.

On Wednesday, March 11, 2009 at a Community Information Breakfast on, more than 100 concerned citizens, city officials, and social service employees gathered at the Junior League of Tulsa Headquarters to learn how they could become involved in **The Front Porch Project® of Tulsa**.

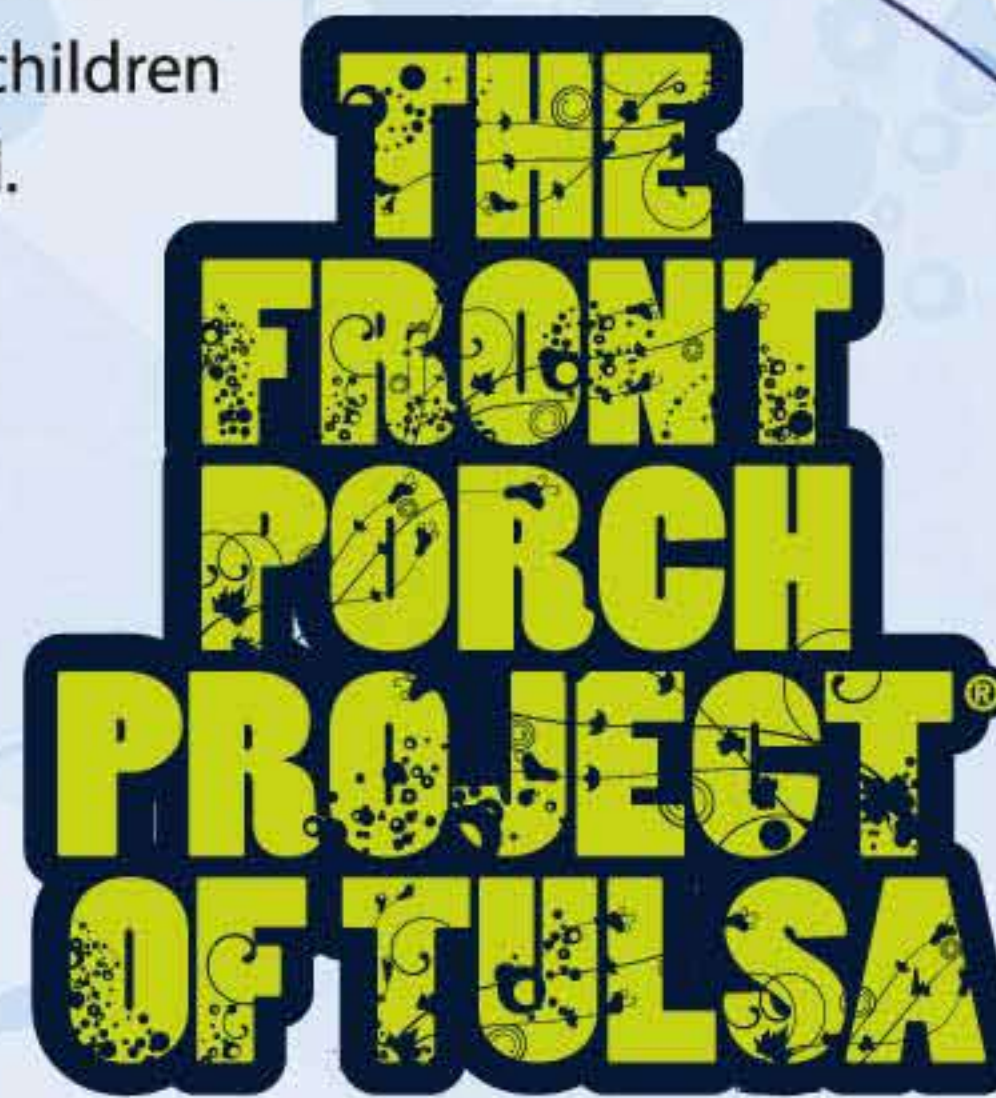
The breakfast was presented by The Parent Child Center of Tulsa and the Junior League of Tulsa and featured guest speaker Ann Doyle, Program Manager of Devereux Kids, who successfully implemented The Front Porch Project® in Tampa, Florida. During the breakfast, we announced trainings to be offered in the Tulsa area which would train participants in the methods of preventing child maltreatment even at the earliest stages.

Since its implementation, participants of **The Front Porch Project® of Tulsa** have seen the benefits of this program for their families and the community.

A survey was conducted of the first class participants by American Humane Society and provided the following results:

- More than 350 people and 170 families have benefitted from Front Porch interventions
- 100% feel that their awareness of interactions involving children has heightened since completing **The Front Porch Project® of Tulsa** training
- 100% had the opportunity to intervene using the Front Porch Skills helping in over 100 different situations

We are excited about the opportunity **The Front Porch Project® of Tulsa** has given us to promote the return of neighborly problem solving, community compassion and caring for children!

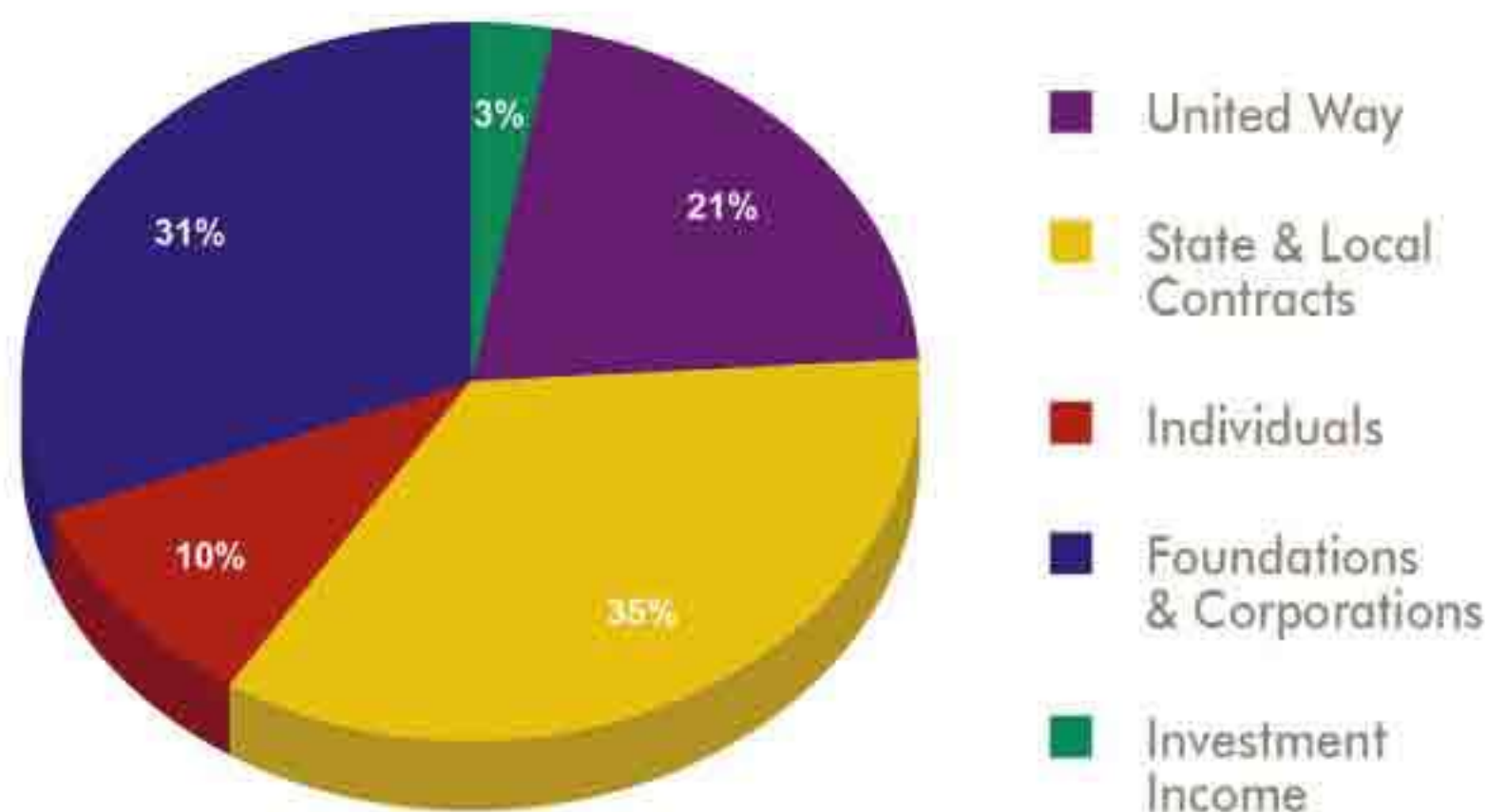

It is a tremendous privilege to honor him as the 2009 Guardian Angel for his invaluable work on behalf of PCCT.

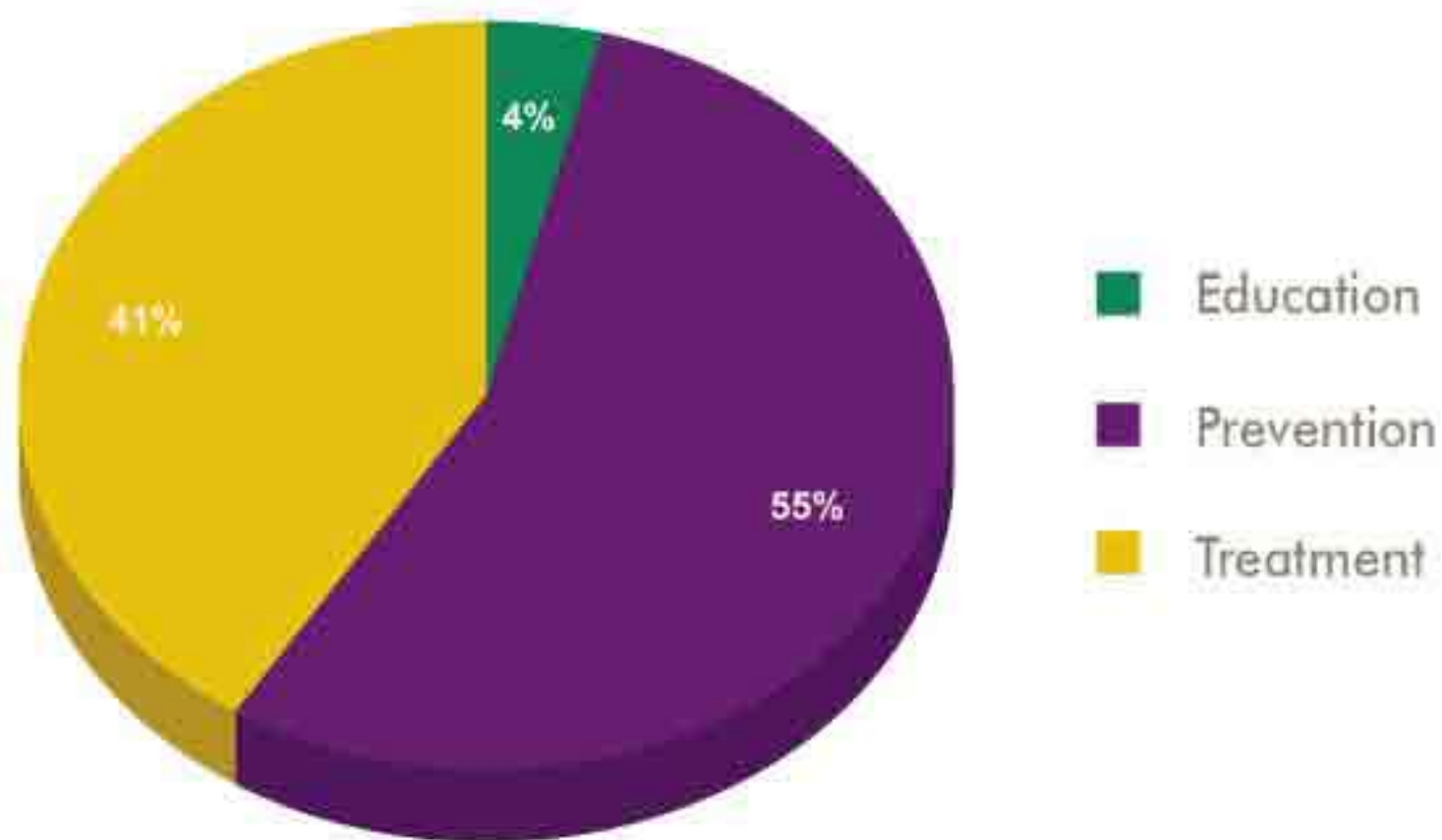

# COLLABORATION

In July 2009, The Parent Child Center of Tulsa Supervised Visitation Program began partnering with Family and Children's Services on the **Tulsa Families Together Project**. Funding for this continuum of supervised visitation services for DHS involved families came by way of several different avenues: leveraging the United Way Venture Grant that F&CS and PCCT partnered to obtain and other local donors obtained by Lynn Sossamon, the Director of the Tulsa County Child Protection Coalition.

This collaboration has helped the Supervised Visitation Program expand in terms of who it serves and the types of services it provides.

Through the **Tulsa Families Together Project**, the Supervised Visitation Program provides supervised visitation to families whose children have been removed into state custody. Families who are working towards reunification receive supervised visits with their children.

Prior to the **Tulsa Families Together Project**, PCCT only provided observational visitation, a type of supervised visitation in which the professional visit supervisor is typically uninvolved, intervening during the visit only if there is a rule violation or safety concern.

When the **Tulsa Families Together Project** began, PCCT began offering a new type of visitation called supportive visitation, a type of visitation in which the professional visit supervisor is more involved during the visit. The professional offers parenting support and coaching to the parent(s) during the visit. This support involves education on developmentally age appropriate behaviors and toys, positive guidance and discipline, and positive parenting techniques.

PCCT has received much positive feedback regarding the **Tulsa Families Together Project** from Child Welfare staff and clients.

The Trailblazer Campaign is made up of select companies who agree to conduct an early campaign for Tulsa Area United Way with outstanding results, providing an example of community caring for the rest of the community to follow.
