

## Letter from the Board President Steve Wright



With completion of our annual report, it seems appropriate to look back briefly on the past year and highlight a few outstanding moments. The Parent Child Center has evolved over 40 years focused on “*preventing child abuse through education, treatment and advocacy*”. We remain thankful for the vision of founding executive director, **Claudette Selph**, the support of **Tulsa Area United Way** and many others for their contribution in shaping this organization.

The **Board of Directors** is very appreciative of **Desiree Doherty, Executive Director**, for her leadership and passion to extend services to find hope, even among the trauma of child abuse and neglect. She and the staff (allow me to mention just a few... **Annette Wallace**, Director of Client Services, and program managers **Steve Hahn**, **Sarah Neyman** and **Ashleigh Kraft**) should be recognized for making The Parent Child Center a leader among Tulsa area nonprofits in the areas of best practice, quality improvement and outcome evaluation.

This year our **staff** continued to expand client services across all three prevention modules: **Community Education, Family Support Services, and Therapeutic Services**. Measuring client contact is one important objective or indication of our progress; however independent program evaluation is another critical measurement that our programs are both effective and delivered to professional standards. Research specialist **Nicholas M. Dubriwny, MSW, OU-Tulsa Center for Applied Research, under the direction of Dr. Chan Hellman**, delivered his evaluation of seven Parent Child Center programs each studied for significant improvement in client outcomes. The results are very gratifying and reinforce the quality and effectiveness of these critical programs. I want to list the programs briefly, but refer you to the full report on our website for a better understanding of his evaluation.

The **Board of Directors recognizes** that expanding client support and services requires additional funding and we have a lot of people to thank for our success. **Don Hardin**, a successful businessman, family man and supporter of The Parent Child Center for many years along with his wife, **Pat** volunteered his time to lead staff, management and board members through a comprehensive strategic training. The hours spent together raised divergent perspectives and resulted in a specific list of critical issues to sharply define our direction.

Our successful fund raising is attributable to a broad range of support from a lot of fantastic and caring people but let me point out a few who helped make Toyland Ball 2013 a record breaking event. **Nancy Moore**, Development Director at The Parent Child Center, provides skillful supervision for our fund raisers. Great thanks to **Irene** and **Stan Burstein**, and **Lisa Antry** and her husband **Steve** for their gifts and continued commitment to parents and children in our community.

Toyland Ball takes enormous organization and commitment from many people, all critical to making the event a success. For the last several years we have been led superbly by “super-volunteer” and co-chair **Jennifer Legler** and her talented colleague **Melody Hughes** from the PCCT staff. ## Letter from the Executive Director Desiree Doherty



Dear Friends,

2012 was a year of great progress and growth for The Parent Child Center of Tulsa. We reached over 45,000 parents and children with at least one of our programs or services.

The area of biggest growth has been in our Primary Prevention Community Education programs. **Kids on the Block puppets** performed in more elementary school classrooms in Tulsa and surrounding communities than ever before and, in partnership with the **Tulsa Drillers**, performed for large groups of children attending Drillers games at ONEOK Field. The puppets empower children from pre-K to 5<sup>th</sup> grade to speak up to a trusted adult to get help if they are not safe. The **Sherman E. Smith Family Foundation** is invested in this success.

Our **Never Shake A Baby** program also saw record numbers of infant caregivers in 2012. We more than doubled the number of moms and family caregivers of newborns that received education on the “Period of Purple Crying” about safely dealing with inconsolable infant crying. We are grateful to **Blue Cross Blue Shield’s** Healthy Kids, Healthy Families Initiative for their support which made this possible.

One of our most significant achievements of 2012 was the launch of a three year Infant Mental Health Community Consultant (IMHCC) pilot project. Our goal in this project is to provide expertise to and links between those who make decisions and provide services for infants and toddlers in state custody in Tulsa, Oklahoma. Based on research from the **Zero to Three National Center for Infants, Toddlers and Families**, we provide training and facilitation for judicial, medical, child welfare, higher ed and community-based children's mental health providers. Dr. Stacey Leakey leads this project for PCCT, and the **Charles and Lynn Schusterman Family Foundation** provides support as part of their child advocacy priority.

It's all about relationship, and we are grateful for the relationship we have with you, our friends and supporters, who make this possible mission of strengthening families to prevent child abuse and neglect.





## Program Evaluation Highlights

### **Primary Prevention: Community Education - Kids on the Block**

Teacher evaluation showed overwhelmingly positive results.

### **Primary Prevention: Community Education - Never Shake a Baby**

Follow up interviews showed a high percentage of recipients read (or watched) the material and shared it with another caregiver.

### **Secondary Prevention: Family Support Services - Great Beginnings and SafeCare**

Improved home safety and improved parent/child relationships.

### **Tertiary Prevention: Therapeutic Services - Adult Treatment**

Evaluation showed reduction in risk for abuse and neglect on every scale.

### **Tertiary Prevention: Therapeutic Services - Child Therapy**


Both caregivers and children show improved results.

Overwhelming positive scores having positive impact on children.


